



County General: Jail \$3,000 from Lagoon to Building Repairs


Kyle Lechien moved to approve the transfers and Karen Mealy 2<sup>nd</sup> and the vote was 5/0.

There being no further comment Kyle Lechien made the motion to adjourn the meeting at 7:17 p.m. with a second by Ryan Goodspeed and carried 5/0.






