

BLACKFORD COUNTY COUNCIL
MINUTES OF July 3, 2019

The Blackford County Council met at 7:00 p.m. on the first floor of the Blackford County Courthouse located at 110 W Washington Street, Hartford City, Indiana for the regular monthly meeting on Wednesday, July 3, 2019.

President Dan Borgenheimer called the meeting to order.

Those members answering roll were Dan Borgenheimer, Jack Beckley, Kyle Lechien, Patrick Cale and Ryan Goodspeed and Fred Tobey. Karen Mealy was absent.

Also present were: Mary Beal, Max Bennett and Auditor Sharon Hartley.

The minutes of the June 5, 2019 Regular Council meeting were approved as Presented on a motion by Kyle Lechien and 2nd by Patrick Cale. The vote was 5/0. (Beckley was absent June 5 and Mealy is absent tonight).

Ryan Goodspeed reported Economic Development will host a "Launch Your Own Business" workshop in the near future.

Fred Tobey reported Blackford Development will hold a meeting on July 10 to look at drawings of the proposed pavilion to be erected on the corner of Main and Jefferson. Also, the former Swifty building on the south side of Hartford City will be torn down soon as will the house just north of there.

The upcoming budget meetings were discussed. Fred Tobey made a motion to begin the August 5, August 7 and August 21 meetings at 6:00 p.m. instead of 7:00 p.m. Ryan Goodspeed 2nd and the vote was 6/0. The August 5 & 7 meetings will be for Council to make cuts and the August 21st meeting will be for appeals with time for department heads to speak.




Co. Gen. Election \$81.96 from Printing to Operating Supplies


There being no further comment Kyle Lechien made the motion to adjourn the meeting at 7:40 p.m. with a second by Patrick Cale and carried 6/0.






